a. Prince William Sound Rural Regional Citizens' Advisory Council/City of Valdez marine vessel guidance workshop discussion (*Baczuk, Higman*)

Guidance for marine vessels confronted with a tsunami hazard needs to be updated, taking into consideration Alaska's complex shorelines. Current key issues are advice is poor and vague, people are not receiving it and in Alaska it will be different everywhere you go. Funding for a workshop to discuss new guidance for marine vessels is in place, will tentatively be held in June of 2024. During this workshop, Hig is hopeful to construct a report that lays out a foundation to build better guidance on what the vessel operator should do in case of a Tsunami. B. Salisbury would like the Commission to bring awareness to this issue by writing a resolution that this is a problem which needs attention and encourages people to participate in discussions.

N. Murray presented on his work trip to Maule Chile to view how the city recovered from the damage to their bridges and roadways following the magnitude 8.8, 2010 earthquake that they experienced.

c. ASCE/AECOM Probabilistic Tsunami Hazard Assessment (Salisbury) 1:30 pm

B. Salisbury discussed the deterministic maps and models that show scenarios of what is most likely to happen during a Tsunami from a probable earthquake or landslide. Models help us to better understand who is at risk and how great that risk may be.

Organization Updates:

- a. DHS&EM (Fisher, Picasso) Update to State Hazard Mitigation plan, draft plan will be out to public comment possibly in June. Still communicating with Victoria Salena about BRIC. NEHRP is coming to investigate and contribute to the 60th Anniversary of 1964 earthquake.
- b. DGGS (Salisbury) DGGS is designing a web service under the NTHMP that will allow us to work with the inundation maps and people in our communities to design evacuation plans in case of an earthquake or tsunami. B. Salisbury is gearing up for West Susitna Basin State Map Project. In just a few months USGS plans to publish earthquake induced ground failure liquification maps for Anchorage. Which will

The subject of the discussion was around the FEMA publication that estimates earthquake risk, that is, financial loss due to shaking ground around the United States. The publication is used to justify funding levels through FEMA's NHRP grant program. M. West says that the underlying risk of hazard has not been updated for Alaska since 2007 and does not accurately represent Alaska in risk of loss. B. Salisbury will review the report and start making a list of items that are not included in the risk of loss and the Commission can discuss it further.

Dialogue revolved around funding and how the Commission can make a difference on future reports.
