#### I. OPENING BUSINESS

- John Aho (Chair) called meeting to order approx 9:15 a.m. Commission members
  John Aho, Gary Carver, Rich Koehler, Bud Cassidy, Laura Kelly, Robert Scher, and
  Gayle White present (quorum established); Ann Gravier, Roger Hansen, Dan Mahalak
  and David Miller absent (note there were problems with the teleconference setup; it
  was unknown if the absent members tried linking into the meeting but were
  unsuccessful). April Woolery, DGGS Administrative Assistant, excused (see
  Administrative Matters, VIII).
- Meeting agenda approved; added Fairbanks are seismic zones under New Business
   (VI) and discussion with Boards & Commissions under Chair's report (VII)

#### **VI. NEW BUSINESS**

- Future briefings: Aho will try to get Tom O'Rourke (Cornell Univ) to Anchorage in future to present his talk The New Normal for natural Disasters, which he delivered at the 2012 EERI meeting and was excellent. Scher suggested the Commission may be more interested in touring the State's emergency operations facility (on JEBR), versus the MOA center.
- Scher concerned about a disconnect between the seismologic information available for the known multiple active seismic zones around Fairbanks (the second most densely populated area in Alaska) and that information needed by engineers to assess and design for that seismic hazard (e.g. credible earthquake magnitudes, recurrence frequency, 'fault' source models, etc.); asked which agency the Commission could approach about developing such parameters (e.g. DGGS, AEIC, USGS, other). Koehler said DGGS is currently doing some further studies of these source zones; Carver pointed out similar work also was done by others but is proprietary. Scher suggested Commission could develop a policy recommendation, and give it to the Fairbanks area legislators, requesting funding for DGGS to work on this (no motion topic tabled).

#### VII. REPORTS

- Chair: Aho again highlighted upcoming presentation by Lloyd Cluff on 11 September; reminded committee chairs they are responsible for a one-page summary of their committee's activities for the ASHSC annual report; and no news on the EERI 2014 meeting/conference in Anchorage. Aho reviewed discussions with the Boards and Commissions office: they have requests for reappointment from Aho, Hansen, and Miller; still no letter/application from Gravier (to replace Mark Roberts); still looking for one 'Local Government Representative'; will be making their selections by mid-Aug; and clarified that while they appreciate the Commission providing names for replacements, the Commission should not feel obligated to do so as it is ultimately their responsibility.
- Schools Committee: Kelly briefed Commission on status of ATC's upgrade of FEMA's RVS procedure – have revised and added a second page to FEMA form 154; have

- circulated new form around the nation for testing, initial feedback encouraging. Kelly will present a briefing of the new RVS procedure at the Commission's Sep meeting.
- Insurance Committee: White insurance handout is available on the ASHSC website.
   Scher volunteered to make sure the MOA Building Safety Department has it for the public.
- Earthquake Scenario Committee: Carver informed Commission that the Cascadia white paper has been submitted to DGGS for publication intends to add a revision from Scher Koehler pointed out such a change must be made quickly, as the document is now moving through DGGS. Carver had no update on FEMA's Kodiak HAZUS study; solicited Commission's thoughts on the depth and extent of the final report (e.g. background geology, paleoseismology, results, recommendations, etc.) Commission tabled discussion until FEMA completes their study. Suggestions for other communities for future earthquake scenario studies included Sitka and Unalaska/Dutch Harbor.
- Hazards Identification Committee: Koehler will give his 'beach ball' presentation at the Commission's Sep meeting. Koehler stated Cascadia paper in process for publication by DGGS looking for originals of the figures (Carver & Kelly?). DGGS Alaska Quaternary fault database project nearing completion; resolving final issues with the metadata; will first be released as digital data files, followed later by a printable document summarizing the project and general mapping. Koehler has finished his white paper on an Alaska earthquake clearinghouse will forward to Aho for distribution.
- Education and Outreach Committee: Scher gave Aho draft letter to Alaska Attorney General regarding Commission's question about protection for post-earthquake building inspection team members from civil liability; working on white paper on the value of seismic instrumentation for engineers, planners, and policy makers; has contacted Kurt Byers (Alaska Sea Grant) to link with their E&O program; working on a glossary of terms for the Commission; will be meeting with the Alaska licensing board (AELS) regarding our policy recommendation 2011-2 (seismic training for engineers).
- Response & Recovery Committee: No report (Gravier absent).
- Partnering Committee: Nothing to report (Aho).

## **VIII. ADMINISTRATIVE MATTERS**

- The Commission's staff representative, April Woolery, will be going on maternity leave Aho will contact Rod Combellick (DGGS) about a replacement.
- Koehler indicated \$9,182 spent in 2011/12 (out of our \$10,000 budget don't know if that includes Lloyd Cluff's expense request). No report on the Commission's 2012/13 budget, or update on status of website (Woolery excused)
