## **I. OPENING BUSINESS**

- Call to Order-*Scher*; Roll call – John Aho, Ann Gravier, Laura Kelly, Robert Scher, De Anne Stevens, and Michael West were present. Charity Carmody had a scheduling conflict and arrived at 10:40 a.m. Gary Carver and Michael Holman were excused. April Woolery from DGGs was also present. Guests: None
- Approval of the Agenda – Kelly moved, West seconded. All in favor, agenda approved with additions: Alaska Earthquake Monitoring Work Group and Earthquake Early Warning Group.
- Ethics Act – No conflicts to report.
- Roster – Still need two Local Government representatives. Names of candidates have been forwarded to Boards and Commissions.
- Election of Commission Chair and Vice-Chair: West nominated, Gravier seconded to nominate Buzz Scher for Chair. All in favor. Aho moved, West seconded to nominate Kelly for Vice-Chair. All in favor.

## **II. OLD BUSINESS**

- 11 March Meeting Minutes – West moved, Aho seconded. Minutes approved with no changes.
- Iniskin Earthquake Briefing Memo – Stevens: One-page report on the event in January. Commission members to review prior to posting online. Discussion of effects of event.
- Proposed ASHSC 2016 Policy Recommendations - All: At the March 2016 meeting, two draft policy recommendation updates were forwarded to members for review. Discussion of Alaska post-earthquake online clearing house. Motion to adopt failed five to one: deferred for more information. Discussion of draft policy recommendation regarding earthquake engineering basic knowledge requirements for professional engineering licensure. Aho motioned, Kelly seconded, to accept. Discussion followed. Motion to adopt failed unanimously. Aho moved, Gravier seconded, to reconsider adoption after further discussion with other groups. All in favor.
- Native Village of Noatak questions about seismic and infrastructure issues – Scher: Discussed at March meeting, letter of response to be reviewed by commission members. Discussion of ASHSC role in disseminating information. Aho moved, West seconded to send the letter with references for information cited. All in favor.
- Western States Seismic Policy Council (WSSPC) Draft Policy Recommendations – All: 2016 Policy Recommendations to be updated by WSSPC members. West motioned, Carmody seconded to accept the WSSPC draft policy recommendations. All in favor. Ann Gravier will attend the WSSPC annual meeting.

  - *Kodiak Earthquake Scenario Report* – No new updates at this time.
