- FEMA Kodiak HAZUS Study FEMA seems to have stalled in completing the study. The Commission will consult with Carver and decide how to proceed.


#### III. NEW BUSINESS

- Commission Projects and Activities Kelly, Aho and Dvorak are participating with EERI on school initiative programs. Gravier and Kelly will work together on securing funding to continue Rapid Visual Screening (RVS) of schools in Alaska. Gravier should hear back from FEMA on funding in about 60 days.
- Chair Report Scher: the state is taking comments on adopting the 2012 building code (2009 code currently in use). Scher forwarded comments.

seismic activity for the AEC. West shared a letter regarding changes to AEC field commitments based on funding cuts. West will send update map showing Earthscope deployment progress. DHS&EM recently distributed preparedness information. Gravier will send this to Commission members for review. FEMA hospital safety course will be offered soon, October 4, 8-5 in Anchorage. Contact Gravier for information on future training. DGGS has several new publications available on its website, and is working on a new tsunami report for Kodiak communities. DGGS will hire a new neotectonics expert by the end of 2016.
